For what purposes are your personal data used?

For how long can your personal data be stored?

What are the legal grounds for processing data?

The legal grounds for processing data is the pre-contractual relationship in which the candidate is involved.

Who are your data disclosed to?

Personal data are not disclosed to third parties, unless we are legally required to do so.

What are your rights with regard to processing data?

As subject/proprietor of the data, you have the right to obtain confirmation of the existence of processing of data, to access your personal data, to request correction of inexact data or, where appropriate, to request removal when, among other justifications, the data are no longer required for the purposes for which they were gathered or if the interested party withdraws consent.

FUNDACION LA LABORAL. CENTRO DE ARTE, CREACION INDUSTRIAL Y PROMOCIÓN CULTURAL shall process and store your data in compliance with current regulations, without prejudice to the limitation of processing of data you may request at any time.

In certain circumstances you can exercise your right to portability of data, which will be transmitted to you or the new controller of data you assign in a structured, commonly used and machine readable format.

You are entitled at any time to revoke the consent given for the processing of data for the purposes agreed.
